### VI. NEW BUSINESS:

### A. Discussion and Appointment of Directors for Open Board Seats

Adrian Madhosingh gave the report. Director Sharon Danaher made a motion to nominate Bill O'Brien for the director position vacated by Jim Crouse. The motion was seconded by Secretary Owens; approved unanimously. Bill O'Brien is officially a Board Director. Bill O'Brien joined the Board members at the table at 7:38pm. Adrian Madhosingh made a motion to reconsider allowing a revote for Russell Stone for the director position vacated by Bill DeMare. The motion was seconded by Secretary Owens. Unanimous consent to reopen a previous Board decision within the last twelve (12) months is required: A voice vote was recorded; YEA= President Madhosingh, Vice President Kormanik, Director Campbell, Director Danaher, Director Owens, Director O'Brien, Director Hanson. NAY=Director Miley. MOTION fails to pass 7-1. The Board will continue looking for a replacement Board member.
