Fieldstone Landscape is doing the repairs and will bill the county.
- C. Update Board on Tree Mart Royal Palms Van Chandler gave the report. The Fieldstone Landscape quote was \$16,193.00, so we went with the Tree Mart quote of \$11,000.00 (approximately \$2,000.00 per palm). The Tree Mart quote does not include boulders, which will be purchased from a separate vendor.
- **D.** Update Board on Florida Flame Red Maples- Van Chandler gave the report. The maples went in today at John R. Miley Park. Fieldstone Landscape will install bubblers to water the maples daily for the next thirty (30) days.
