  - **4.** Sussex & Lytton: cut down Oak tree and grind stump for \$1,300.00. A motion was made by Suzanne Fernandez to approve the quote. The motion was seconded by Chris Rule. **All in favor, the motion passed.**
  - 5. Mama Oak removal for \$2,000.00. A motion was made by Suzanne Fernandez to table to allow more time for removal quotes. The motion was seconded by Andrew Titen. **All in favor, the motion passed.**
